

# COPY OF REGULATION OF THE MINISTER OF FINANCE NUMBER 123/PMK.04/2011 CONCERNING

THE FOURTEENTH AMENDMENT O DECISION OF THE MINISTER OF FINANCE NUMBER 89/KMK.04/2002 CONCERNING PROCEDURES FOR GRANTING CUSTOMS AND EXCISE EXEMPTION ON IMPORTED GOODS FOR THE PURPOSES OF INTERNATIONAL BODY AND ITS OFFICIALS COMMISSIONED IN INDONESIA

> BY THE GRACE OF GOD ALMIGHTY THE MINISTER OF FINANCE,

- Considering : a. That *Deutsche Gesellschaft für Technische Zussammenarbeit* (GTZ), a technical cooperation body of Federal Republic of Germany, has been stipulated as an international body entitled to facilities of import tax exemption based on the Decision of the Minister of Finance Number 89/KMK.04/2002 concerning Procedures for Granting Customs and Excise Exemption on Imported Goods for the Purposes of International Body and its Officials Commissioned in Indonesia as several times amended most recently by the Regulation of the Minister of Finance Number 135/PMK.04/2010;
  - b. That State Secretariat via letter Number: B-762/Setneg/Setmen/KTLN/KL.01/04/2011 on April 14, 2011 expresses suggestion concerning amendment on the name of international body as has been stipulated in the Appendix of the Decision of the Minister of Finance Number 89/KMK.04/2002 concerning Procedures of Granting Customs and Excise Exemption on Imported Goods for the Purposes of International Body and Its Officials Commissioned in Indonesia as several times amended most recently by the Regulation of the Minister of Finance Number 135/PMK.04/2010, i.e. Deutsche Gesellschaft für Technische Zussammenarbeit (GTZ) amended into Deutsche Gesellschaft für Internationale Zussammenarbeit (GIZ);
  - c. That the international body, in accordance with the suggestion by State Secretariat as referred in letter b, has fulfilled the requirements in order to be granted import tax exemption in accordance with the custom provisions;
  - d. That based on consideration as referred in letter a, letter b, and letter c, it is necessary to stipulate the Regulation of the Minister of

## DECIDES:

To Stipulate : REGULATION OF THE MINISTER OF FINANCE CONCERNING THE FOURTEENTH AMENDMENT ON DECISION OF THE MINISTER OF FINANCE NUMBER 89/KMK.04/2002 CONCERNING PROCEDURES FOR GRANTING CUSTOMS AND EXCISE EXEMPTION ON IMPORTED GOODS FOR THE PURPOSES OF INTERNATIONAL BODY AND ITS OFFICIALS COMMISSIONED IN INDONESIA.

# Article I
