REGULATION OF THE FINANCE MINISTER
NUMBER 150/PMK.011/2009
ON
DETERMINATION OF THE RATE OF IMPORT DUTY ON IMPORTED SUGAR
BY THE GRACE OF THE ONE ALMIGHTY GOD

MINISTER OF FINANCE,

- Having considered :
- a. that to maintain the stability of sugar price within the country with due regard to the interest of consumers, it is necessary to enact import duty on imported sugar;
 - b. that based on the consideration referred to in letter a and to implement the provision of Article 12 paragraph (3) of Law Number 10 of 1995 regarding Customs as has been amended by Law Number 17 of 2006, it is necessary to enact the Regulation of Minister of Finance on Import Duty on Imported Sugar;

- Having observed :
1. Law Number 10 of 1995 on Customes (State Gazette of the Republic of Indonesia Number 75 of 1995, Supplement to the State Gazette of the Republic of Indonesia Number 3612) as has been amended by Law No 17 of 2006 (State Gazette of the Republic of Indonesia Number 93 of 2006, Supplement to the State Gazette of the Republic of Indonesia Number 4661);
 2. Presidential Decree Number 20/P of 2005;
 3. Regulation of the Minister of Finance Number 110/PMK.010/2006 on Goods Classification System and Import Duty, as amended several times and last by the Regulation of the Minister of Finance Number 233/PMK.022/2008;

HAS DECIDED :

To enact : **REGULATION OF THE MINISTER OF FINANCE ON
IMPORT DUTY ON IMPORTED SUGAR.**

Article 1

To enact import duty on imported sugar as has been stipulated in the Appendix of this Regulation of Minister of Finance, which is an integral part of this Regulation of Minister of Finance.

Article 2

The provisions in this Regulation of Minister of Finance, shall be applicable to import of goods, of which the Customs Notice has obtained registration number from the Customs office at the port of entry at the time this Ministerial Regulation is applicable.

Article 3

With the effectiveness of this Regulation of Finance Minister, the provisions concerning the rate of Import Duty as governed under the Regulation of Finance Minister Number 110/PMK.011/2006 concerning Goods Classification System and Import Duty as amended several times and last by the Regulation of Finance Minister Number 233/PMK.011/2008 to the extent it is governing the products referred to in the Appendix of this Regulation of Finance Minister, shall be declared no longer effective during the effectiveness of this Regulation of Finance Minister.

Article 4

This Regulation of Finance Minister shall be effective as of 1 October up to the 31 December 2009.

In order that this Regulation is known to the general public, it is hereby ordered that this Regulation of Finance Minister be promulgated in the Official Gazette of the Republic of Indonesia.
