GENERAL GUIDELINES AND POSITIVE CORRECTION ON GENERAL
ALLOCATION FUND AND POSITIVE CORRECTION ON SPECIFIC ALLOCATION
FUND FOR FISCAL YEAR 2010

THE MINISTER OF FINANCE,

- Considering : a. that in the establishment of a positive correction of general allocation funds and positive corrections of Specific Allocation Funds for Fiscal Year 2010 as allocated in the Act No. 10 Year 2010 on the State Budget of the Republic of Indonesia for Fiscal Year 2011 as amended by Act No. 11 2011, it is necessary to stipulate Regulation of the Minister of Finance on the General Guidelines and positive correction of general allocation funds and positive corrections of Specific Allocation Funds for Fiscal Year 2010;
- In View of : 1. Act No. 33 of 2004 on Financial Balance between Central and Regional Government (State Gazette of the Republic of Indonesia Year 2004 Number 126, Supplement to State Gazette No. 4438);
2. Act No. 47 Year 2009 on the State Budget of the Republic of Indonesia for Fiscal Year 2010 (State Gazette of the Republic of Indonesia Year 2009 Number 156, Supplement to State Gazette of the Republic of Indonesia Number 5075) as amended by Act No. 2 of 2010 (State Gazette Republic of Indonesia Year 2010 Number 69, Supplement to State Gazette of the Republic of Indonesia Number 5132);
3. Act No. 10 Year 2010 on the State Budget of the Republic of Indonesia for Fiscal Year 2011 (State Gazette of the Republic of Indonesia Year 2010 Number 126, Supplement to State Gazette of the Republic of Indonesia Number 5167), as amended by Act No. 11 of 2011 (State Gazette of the Republic of Indonesia Year 2011 Number 81, Supplement to State Gazette of the Republic of Indonesia Number 5233);
4. Government Regulation Number 55 Year 2005 on Fund Balance (State Gazette of Republic of Indonesia Year 2005 Number 137, Supplement to State Gazette of the Republic of Indonesia Number 4575);

5. Presidential Decree No. 6 of 2011 on the General Allocation Fund Provincial and District / Municipal Fiscal Year 2011;
6. Presidential Decree No. 56 / P of 2010;
7. Minister of Finance Regulation No. 126/PMK.07/2010 on Implementation and Accountability of Budget Transfers to the Regions;
8. Minister of Finance Regulation No. 216/PMK.07/2010 on General Guidelines and Allocation of Specific Allocation Fund for Fiscal Year 2011, as amended by Regulation of the Minister of Finance No. 42/PMK.07/2011;

DECIDES:

To stipulate : REGULATION OF THE MINISTER OF FINANCE CONCERNING GENERAL GUIDELINES AND POSITIVE CORRECTION ALLOCATION ON GENERAL ALLOCATION FUND AND POSITIVE CORRECTION ON SPECIFIC ALLOCATION FUND FISCAL YEAR 2010.

Article 1

- (1) Positive correction on General Allocation Fund for Fiscal Year 2010 is the underpayment of the General Allocation Fund Allocations for Fiscal Year 2010.
- (2) Allocation positive correction on General Allocation is set at IDR 887.223.000 (eight hundred and eighty-seven million two hundred twenty three thousand rupiahs) with the details as contained in Attachment I, which are not an integral part of this regulation.
- (3) Positive Correction on Specific Allocation Fund for Fiscal Year 2010 is an underpayment of Allocation on Specific Allocation Fund for Fiscal Year 2010.
- (4) Positive correction allocation on Specific Allocation Fund is set at IDR 900.000 (nine hundred thousand rupiahs) with the details as contained in Attachment II that are not an integral part of this regulation.
- (5) The use of Positive Correction allocation on Specific Allocation Fund as described in paragraph (4), delegated to the regions in accordance with the conditions, needs, and priorities based on general guidelines and technical instructions use of Specific Allocation Fund for Fiscal Year 2011.

Article 2

- (1) Positive Correction on General Allocation Fund and Positive Correction on Specific Allocation Fund for Fiscal Year 2010 as referred to in Article 1 is part of the Balanced Fund and stipulated in the State Budget

Amendment for Fiscal Year 2011.

- (2) Positive Correction on General Allocation Fund and Specific Allocation Fund as referred to in Article 1 is part of the budgeted revenue in the Regional Revenue and Expenditure Budget Amendment for Fiscal Year 2011.

Article 3

Positive corrections on General Allocation Fund and Positive corrections on Specific Allocation Fund as referred to in Article 1 is provided through the issuance of Implementation Checklist Budget Fiscal Year 2011 on 999.05 Budget Section (Management Transfer to Region).

Article 4

- (1) Positive corrections on General Allocation Fund and Positive corrections on Specific Allocation Fund for Fiscal Year 2010 as referred to in Article 1, distributed by transfer from the State Treasury to the account of the Region.
- (2) Distribution of positive corrections on General Allocation Fund carried out at once from the number of positive correction of the General Allocation Fund for Fiscal Year 2010 as referred to in Article 1 (2).
- (3) Distribution of positive corrections on Specific Allocation Fund implemented as well as from the number of positive correction on Specific Allocation Fund for Fiscal Year 2010 as referred to in Article 1 (4).

Article 5

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
