THE NINTH AMENDMENT TO REGULATION OF THE MINISTER FINANCE  
NUMBER 110/PMK.10/2006 ON DETERMINATION OF GOODS  
CLASSIFICATION SYSTEM AND IMPOSITION OF IMPORT DUTY TARIFF ON  
IMPORTED GOODS

BY THE GRACE OF GOD ALMIGHTY

THE MINISTER OF FINANCE,

- Considering : a. that based on Regulation of the Minister of Finance Number 110/PMK.011/2006 on Determination of Goods Classification System and Imposition of Import Duty Tariff on Imported Goods as amended several times, the latest by Regulation of the Minister of Finance Number 90/PMK.011/2011, has determined Goods Classification System and Imposition of Import Duty Tariff on Imported Goods;
- b. that in order to meet the needs of medicine in domestic and in order to increase the ability of graphics industry, it is necessary to make adjustments to the imposition of import duty tariff on imported goods in the form of products of specific medicinal raw material and specific graphics industrial machine;
- c. that based on the consideration as referred to in point a and b, and in order to implement the provision of Article 12 paragraph (3) of Act Number 10 Year 1995 concerning Customs as amended by Act Number 17 Year 2006, it is necessary to stipulate Regulation of the Minister of Finance on the Ninth Amendment of Regulation of the Minister of Finance Number 110/PMK.011/2006 on Determination of Goods Classification System and Imposition of Import Duty Tariff on Imported Goods;
- In View of : 1. Act Number 7 Year 1994 concerning Ratification of Agreement Establishing The World Trade Organization (State Gazette of the Republic of Indonesia Year 1994 Number 57, Supplement to State Gazette of the Republic of Indonesia Number 3564);

DECIDES:

- To stipulate : REGULATION OF THE MINISTER OF FINANCE THE NINTH AMENDMENT TO REGULATION OF THE MINISTER FINANCE NUMBER 110/PMK.10/2006 ON DETERMINATION OF GOODS CLASSIFICATION SYSTEM AND IMPOSITION OF IMPORT DUTY TARIFF ON IMPORTED GOODS

Article I

1. Amend Attachment II of Number 110/PMK.011/2006 on Determination of Goods Classification System and Imposition of Import Duty Tariff on Imported Goods as amended several times, the latest by Regulation of the Minister of Finance Number 90/PMK.011/2011, which determined import duty tariff on imported goods of specific medicinal raw material products and specific graphics industrial machine, therefore as stated in the Attachment which is an integral part of this Regulation of the Minister of Finance.

Article II

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
