ESTIMATE OF REVENUE SHARING FUND ALLOCATION OF FISHERY
NATURAL RESOURCES OF THE 2012 FISCAL YEAR

THE MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA,

- Considering : that to implement the provision of Article 27 of Regulation of Government Number 55 of 2005 concerning Balance Fund, it is necessary to stipulate a Regulation of Minister of Finance concerning Estimate of Revenue sharing Fund Allocation of Fishery Natural Resources of the 2012 Fiscal Year;

DECIDES:

To Stipulate: REGULATION OF THE MINISTER OF FINANCE
CONCERNING ESTIMATE OF REVENUE SHARING FUND
ALLOCATION OF FISHERY NATURAL RESOURCES OF
THE 2012 FISCAL YEAR

Article 1

- (1) Estimate of Revenue Sharing Fund Allocation of Fishery Natural Resources of the 2012 Fiscal Year in accordance with the Estimate of Fishery Natural Resource income of the 2012 Fiscal Year shall be as stipulated in Act Number 22 of 2011 on State Revenue and Expenditure Budget of the 2012 Fiscal Year.
- (2) Estimate of Revenue Sharing Fund Allocation of Fishery Natural Resources of the 2012 Fiscal Year as referred to in paragraph (1) is Rp120,000,000,000.00 (one hundred twenty billion Rupiahs).
- (3) The details of Revenue Sharing Fund Allocation of Fishery Natural Resources of the 2012 Fiscal Year are attached in Appendix, which constitutes an integral and inseparable part of this Regulation of Minister of Finance.

Article 2

- (1) Distribution of Revenue Sharing Fund Allocation of Fishery Natural Resources of the 2012 Fiscal Year shall be implemented per quarter.
- (2) Distribution of Revenue Sharing Fund Allocation of Fishery Natural Resources of the 2012 Fiscal Year of Quarter I and II is conducted at 15% (fifteen percent) respectively, from the estimate of Revenue Sharing Fund Allocation of Fishery Natural Resources of the 2012 Fiscal Year as referred to in Article 1 paragraph (3).
- (3) Distribution of Revenue Sharing Fund Allocation of Fishery Natural Resources as referred to in paragraph (2) shall be calculated with the realized revenue of Revenue Sharing Fund Allocation of Fishery Natural Resources of the 2012 Fiscal Year of Quarter III and IV.
- (4) Distribution of Revenue Sharing Fund Allocation of Fishery Natural Resources of the 2012 Fiscal Year shall be conducted under the provisions of legislation.

Article 3

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
