THE MINISTER OF FINANCE,

- Considering : that in the context of stipulation of the SpecialAutonomy Fund allocation of Nanggroe Aceh Darussalam Province for 2011 Fiscal Yearthat has been allocated in Act Number 10 of 2010 concerningState Revenue and Expenditure Budget for 2011 Fiscal Year, it is necessary to stipulate aRegulation of the Minister of Finance onSpecial Autonomy Fund Allocation of Nanggroe Aceh DarussalamProvince for2011 Fiscal Year;

DECIDES:

To stipulate : REGULATION OF THE MINISTER OF FINANCE CONCERNING SPECIAL AUTONOMY FUND ALLOCATION OF NANGGROE ACEH DARUSSALAM PROVINCE FOR 2011 FISCAL YEAR.

Article 1

Special Autonomy Fund of Nanggroe Aceh Darussalam Province as referred to in this Regulation of the Minister of Finance shall be part of the Special Autonomy Fund and Adjustment as referred to in Act Number 10 of 2010 concerning State Revenue and Expenditure Budget for 2011 Fiscal Year.

Article 2

Special Autonomy Fund of Nanggroe Aceh Darussalam Province is allocated to Nanggroe Aceh Darussalam Province equal to 2% (two percent) from the ceiling of the National General Allocation Fund or in the amount of Rp4,510,656,496,500 (four billion five hundred ten billion, six hundred and fifty six million four hundred ninety six thousand five hundred Rupiahs).

### Article 3

Special Autonomy Fund of Nanggroe Aceh Darussalam Province as referred to in Article 2 shall be used to finance construction mainly designated to construction and maintenance of infrastructure, empowerment the people's economy, poverty alleviation and education, social, and health funding.

### Article 4

The Use of Special Autonomy Fund of Nanggroe Aceh Darussalam Province as referred to in Article 2 for each fiscal year shall be set further by *Qanun* (rules) of Aceh.

### Article 5

Distribution procedures for Special Autonomy Fund Transfer shall be carried out in accordance with the provisions of legislation.

### Article 6

Functional supervision / examination of the activity implementation and financial management of the Special Autonomy Fund of Nanggroe Aceh Darussalam Province shall be conducted in accordance with the provisions of legislation.

### Article 7

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
