THE MINISTER OF FINANCE OF REPUBLIC OF INDONESIA,

- Considering :
- a. that as the implementation of Article 9 of Government Regulation Number 23 of 2005 concerning Financial Management of General Service Agency, General Service Agency of Revolving Fund Management Institution of Cooperatives and Micro, Small, and Medium Enterprises on the State Ministry of Cooperatives and Micro, Small, and Medium Enterprises has had the service rate that is stipulated based on the Regulation of the Minister of Finance Number 77/PMK.05/2010;
  - b. that the Revolving Fund Management Institution of Cooperatives and Micro, Small, and Medium Enterprises on the State Ministry of Cooperatives and Micro, Small, and Medium Enterprises has been stipulated as a Government Agency that implements the Financial Management Pattern of the General Services Agency based on the Regulation of the Minister of Finance Number KEP-292/MK.5/2006;
  - c. that the State Ministry of Cooperatives and Micro, Small, and Medium Enterprises through Letter Number: 31/M.KUKM.1/XI/2010 dated November 16, 2010 has purposed an amendment proposal to the service rate of General Service Agency of Revolving Fund Management Institution of Cooperatives and Micro, Small, and Medium Enterprises on the

Article I

To amend Appendix to Regulation of the Minister of Finance Number 77/PMK.05/2010 concerning Service Rate of General Service Agency of Revolving Fund Management Institution of Cooperatives and Micro, Small, and Medium Enterprises on the State Ministry of Cooperatives and Micro, Small, and Medium Enterprises, to become as referred to in Appendix, which constitutes an integral and an inseparable part of this Regulation of the Minister of Finance.

Article II

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.
