AMENDMENT TO THE REGULATION OF THE MINISTER OF FINANCE NUMBER
173/PMK.05/2010 CONCERNING PROCEDURE OF RELIEF FUND MANAGEMENT
IN THE FRAMEWORK OF NATURAL DISASTERS COUNTERMEASURES IN
SUMATRA

THE MINISTER OF FINANCE OF REPUBLIC OF INDONESIA,

- Considering :
- a. that in order for the management of Revenue Account of Sumatra Disaster Assistance Fund can be implemented in accordance to the mechanism of The State Budget, it has been stipulated The Regulation of the Minister of Finance No. 173/PMK.05/2010 concerning the Procedures for Management of Funds Assistance in the Framework of Natural Disaster Countermeasures in Sumatra;
 - b. that the activities of the natural disaster countermeasures in Sumatra funded by Grant Sumatra Natural Disaster Assistance Fund is not expected to be completed until the date of December 31, 2011 as regulated in The Regulation of the Minister of Finance No. 173/PMK.05/2010 concerning the Procedures for Management of Assistance Funds in the Framework of Natural disasters Countermeasures in Sumatra;
 - c. that for natural disaster management activities in Sumatra can be resolved, it is necessary to adjust the time for the implementation of natural disaster countermeasures in Sumatra, as referred to in letter b by change some of provisions in the Regulation of the Minister of Finance No. 173/PMK.05/2010 concerning the Procedures for the Management of Assistance Fund in the Framework of Natural Disaster Countermeasures in Sumatra;

d. that based on considerations as referred to in letters a, b, and c, it is necessary to stipulate The Regulation of the Minister of Finance concerning the Amendment to The Regulation of the Minister of Finance No. 173/PMK.05/2010 concerning the Procedures for the Management of Assistance Fund in the Framework of Natural Disaster Countermeasures in Sumatra;

In View of : 1. Presidential Decree No. 56 / P of 2010;
2. The Regulation of the Minister of Finance No. 173/PMK.05/2010 concerning the Procedures for the Management of Assistance Fund in the Framework of Natural Disaster Countermeasures in Sumatra;

Noting : The Regulation of Head National Disaster Countermeasures Agency No. 12 Year 2009 concerning Action Plan for the Rehabilitation and Reconstruction After Earthquake Disaster in West Sumatra Year 2009-2011, as amended by Regulation of the Head of National Disaster Countermeasures Agency Number 7 Year 2011;

DECIDES

To stipulate : REGULATION OF THE MINISTER OF FINANCE CONCERNING AMENDMENT TO THE REGULATION OF THE MINISTER OF FINANCE NUMBER 173/PMK.05/2010 CONCERNING PROCEDURE OF RELIEF FUND MANAGEMENT IN THE FRAMEWORK OF NATURAL DISASTERS COUNTERMEASURES IN SUMATRA

Article I

Several provisions in the Regulation the Minister of Finance No. 173/PMK.05/2010 concerning the Procedures for the Management of Assistance Fund in the Framework of Natural Disaster Countermeasures in Sumatra, is amended as follows:

1. The provisions of Article 5 is amended to read as follows:

- (1) Grant Assistance funds of Sumatra Natural Disaster Countermeasures as referred to in Article 4 of being a source of funding for natural disaster countermeasures in the province of West Sumatra and Aceh province.
 - (2) BNPB head in accordance with the duties and functions stipulated as PA Natural Disaster Countermeasures Assistance Fund of Sumatra as referred to in clause (1).
 - (3) BNPB proposed revisions to the Work Plan and Budget of the Ministry / Agency (RKAKL) and Revised Work Unit Budget Implementation Checklist (DIPA) regarding to accommodate funding and implementation of natural disaster countermeasures in of Sumatra.
 - (4) Based on the Revised DIPA as referred to in clause (3), Authority Center General Treasurer transfers the funds in the Account Revenue Relief to Account KUN.
 - (5) Natural disaster countermeasure activities in Sumatra as referred to in clause (3) completed in Fiscal Year 2011.
2. The provisions of Article 6 is amended to read as follows:

Article 6

- (1) In the case of the natural disaster countermeasures in Sumatra cannot be completed in Fiscal Year 2011 as referred to in Article 5 clause (5), settlement activity will be continued in Fiscal Year 2012.
 - (2) In the case of there are funds remaining in the DIPA as referred to in Article 5 clause (3) that was not realized until the end of Fiscal Year 2011, the fund is a commitment of the government to be allocated from the Budget More remaining (SAL) for disaster countermeasures.
 - (3) Funding for continued settlement activities as referred to in clause (1) comes from SAL as referred to in clause (2).
3. The provisions of Article 12 clause (1) is amended and added a new clause, namely clause (3), so that Article 12 reads as follows:

Article 12

- (1) The deadline for financing the natural disaster countermeasures in Sumatra until the date of December 31, 2012.
- (2) If the financing until the deadline as referred to in clause (1) there is still a balance in the DIPA and balances in the Account Revenue Disaster Assistance, the balance can be used to finance other disaster countermeasure activities.
- (3) Balance in the DIPA and balances in the Account Revenue Disaster Assistance that can be used to finance other disaster countermeasures as referred to in clause (2), excluding the balance allocated for natural disaster countermeasures in the province of Aceh.

Article II

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia
