CONCERNING

IMPOSITION OF SAFEGUARD MEASURES IMPORT DUTY ON THE IMPORT OF
TARPAULIN PRODUCTS MADE FROM SYNTHETIC FIBER IN ADDITION TO
AWNING AND SUNSCREEN

BY THE GRACE OF GOD ALMIGHTY

THE MINISTER OF FINANCE,

- Considering
- a. that based on the provision of Article 70 of Government Regulation Number 34 Year 2011 concerning Antidumping Measure, Countervailing Measure, and Safeguard Measure, to the imported goods besides subject to Import Duty may be subject to Safeguard Measures in the form of Safeguard Measures Import Duty;
 - b. that based on the investigation result of The Indonesian Safeguard Committee (KPPI) there is evidence of surge in the number of imported goods of tarpaulin products made from synthetic fiber in addition to awning and sunscreen that may cause serious injury to the domestic industry;
 - c. that based on the investigation result of The Indonesian Safeguard Committee (KPPI) as referred to in point a, Minister of Trade, through Letter Number: 1069/M-DAG/SD/7/2011 dated July 15, 2011, submit a proposal to the Minister of Finance to impose Safeguard Measures Import Duty on the imported tarpaulin products made of synthetic fiber in addition to awning and sunscreen.
 - d. that based on the consideration as referred to point a, b and c, and in order to implement provision of Article 23D paragraph (2) of Act Number 10 Year 1995 concerning Customs as amended by Act Number 17 Year 2006, it is necessary to stipulate Regulation of the Minister of Finance on the Imposition of Safeguard Measures Import Duty on the Imported Tarpaulin Products made of Synthetic Fiber in addition to Awning and Sunscreen;

DECIDES:

- To stipulate
- : REGULATION OF THE MINISTER OF FINANCE IMPOSITION OF SAFEGUARD MEASURES IMPORT DUTY ON THE IMPORT OF TARPAULIN PRODUCTS MADE FROM SYNTHETIC FIBER IN ADDITION TO AWNING AND SUNSCREEN.

Article 1

On the imported tarpaulin products made of synthetic fiber in addition to awning and sunscreen included in tariff lines ex. 6306.12.00.00, imposed Safeguard Measures Import Duty.

Article 2

Safeguard Measures Import Duty as referred to in Article 1 imposed for 3 (three) years with the following conditions:

2	2 nd year, with 1 (one) year period from the expiration date of 1 st year.	Rp 12.643 /kg
3	3 rd year, with 1 (one) year period from the expiration date of 2 nd year.	Rp 11.643 /kg

Article 3

Safeguard Measures Import Duty as referred to in Article 1 shall be imposed on the importation from all countries, except for product of tarpaulin as referred to in Article 1 produced from the countries as specified in the Attachment which is an integral part of this Regulation of the Minister of Finance.

Article 4

- (1) Imposition of Safeguard Measures Import Duty as specified in Article 1 shall mean:
 - a. Additional Most Favoured Nation; or
 - b. Additional Preference Import Duty based on the applicable schemes of international goods trade agreements, in terms of imports made from the countries included in the schemes of international goods trade agreements intended and comply with schemes of international goods trade agreements.
- (2) In terms of the provisions in schemes of international goods trade agreements not meet, the imposition of Safeguard Measures Import Duty on importation from the countries included in the schemes of international goods trade agreements as referred to in paragraph (1) point b is the addition of Most Favoured Nation.

Article 5

On the imported tarpaulin products as referred to in Article 1 which comes from the countries excluded from the imposition of Safeguard Measures Import Duty as referred to in Article 3 and which comes from the countries cooperate in trade with Indonesia as referred to in Article 4 paragraph (1) point b, importers must submit Certificate of Origin documents.

Article 6

The provisions concerning the imposition of Safeguard Measures Import Duty as referred to in Article 2 fully applicable to imported goods in which the import customs notification has obtained registration number from the Customs Office of entry port from the effective date of this Regulation.

Article 7

1. This Regulation of the Minister of Finance shall be valid for 3 (three) years from the effective date of this Regulation.
2. This Regulation of the Minister of Finance shall come into force on the date of its promulgation.

Article II

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
