SUPPLEMENTARY FUND OF PAPUA AND WEST PAPUA PROVINCES
FOR 2011 FISCAL YEAR

THE MINISTER OF FINANCE,

Considering : that in the context of stipulation of allocation of Special Autonomy Fund and Infrastructure Supplementary Fund of Papua and West Papua Provinces for 2011 Fiscal Year, which is allocated in Act Number 10 Year 2010 concerning State Revenue and Expenditure Budget for 2011 Fiscal Year, it is necessary to stipulate a Regulation of the Minister of Finance on Allocation of Special Autonomy Fund and Infrastructure Supplementary Fund of Papua and West Papua Provinces for 2011 Fiscal Year;

DECIDES:

To stipulate : REGULATION OF THE MINISTER OF FINANCE CONCERNING ALLOCATION OF SPECIAL AUTONOMY FUND AND INFRASTRUCTURE SUPPLEMENTARY FUND OF PAPUA AND WEST PAPUA PROVINCES FOR 2011 FISCAL YEAR.

Article 1

Special Autonomy Fund and Infrastructure Supplementary Fund of Papua and West Papua Provinces as referred to in this Regulation of the Minister of Finance is part of the Special Autonomy Fund and Adjustment as referred to in Act Number 10 of 2010 concerning State Revenue and

Expenditure Budget for 2011 Fiscal Year.

Article 2

Special Autonomy Fund of Papua and West Papua Provinces is allocated to Papua and West Papua Provinces equal to 2% (two percent) of the ceiling of National General Allocation Fund or in the amount of Rp4,510,656,496,500 (four billion five hundred ten billion, six hundred and fifty six million four hundred and ninety six thousand five hundred Rupiahs), which is agreed to be distributed with a proportion of 70% (seventy percent) for Papua Province and 30% (thirty percent) for West Papua Province with the following details:

- a. Special Autonomy Fund of Papua Province is in the amount of Rp3,157,459,547,550 (three trillion one hundred and fifty seven billion, four hundred and fifty nine million five hundred forty seven thousand five hundred and fifty Rupiahs);
- b. and

Special Autonomy Fund of West Papua Province is in the amount of Rp1,353,196,948,950 (one trillion, three hundred and fifty three billion, one hundred and ninety six million nine hundred and forty eight thousand nine hundred and fifty Rupiahs).

Article 3

Infrastructure Supplementary Fund in the context of special autonomy of Papua and West Papua Provinces in the amount of Rp1.400.000.000.000, 00 (one trillion and four hundred billion Rupiahs) is as the following details:

- a. Infrastructure Supplementary Fund of Papua Province is in the amount of Rp800,000,000,000 (eighthundred billion Rupiahs); and
- b. Infrastructure Supplementary Fund of West Papua Province is in the amount of Rp600,000,000,000 (six hundred billion Rupiahs).

Article 4

Special Autonomy Fund of Papua and West Papua Provinces as referred to in Article 2 is mainly designated for education and health care funding.

Article 5

Infrastructure Supplementary Fund of Papua and West Papua Provinces as referred to in Article 3 is mainly designated for infrastructure development funding.

Article 6

Further division of fund revenue as referred to in Article 2 between provinces and regencies / cities shall be carried out in accordance with the provisions of legislation.

Article 7

Special Autonomy Fund of Papua and West Papua Provinces and Infrastructure Supplementary Fund of Papua and West Papua Provinces shall be part of the regional revenue and budgeted in the Regional Revenue and Expenditure Budget for 2011 Fiscal Year for each beneficiary province and beneficiary regency / city of fund.

Article 8

Distribution procedures for Special Autonomy Fund and Infrastructure Supplementary Fund Transfer shall be carried out in accordance with the provisions of legislation.

Article 9

Functional supervision / examination of the activity implementation and financial management of Special Autonomy Fund of Papua and West Papua Provinces and Infrastructure Supplementary Fund of Papua and West Papua Provinces shall be made in accordance with the provisions of legislation.

Article 10

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
