ALLOCATION OF REVENUE SHARING FUND OF NATURAL OIL AND GAS  
MINING NATURAL RESOURCES IN THE CONTEXT OF SPECIAL AUTONOMY IN  
WEST PAPUA PROVINCE FOR 2010 FISCAL YEAR

THE MINISTER OF FINANCE OF REPUBLIC OF INDONESIA,

- Considering : a. that based on Regulation of the Minister of Finance Number 14/PMK.07/2010 regarding Estimate of Revenue Sharing Fund Allocation of Natural Oil and Gas Mining Natural Resources in the Context of Special Autonomy in West Papua Province for 2010 Fiscal Year, as amended by Regulation of the Minister of Finance Number 183/PMK.07/2010, Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources in the Context of Special Autonomy in West Papua Province for 2010 Fiscal Year has been stipulated;
- b. that based on the reconciliation result of calculation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources Quarter IV for 2010 Fiscal Year, it is necessary to make adjustments to Revenue Sharing Fund Allocation of Natural Oil and Gas Mining Natural Resources in the Context of Special Autonomy in West Papua Province for 2010 Fiscal Year;
- c. that based on the considerations as referred to in point a and point b, it is necessary to stipulate a Regulation of Minister of Finance on Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources in the Context of Special Autonomy in West Papua Province for 2010 Fiscal Year;

Noting : Decree of the Minister of Energy and Mineral Resources Number 2466 K/30/MEM/2009 on Stipulation of Producing Regions and Calculation Basis of Shares of General Mining Producing Regions, Geothermal, Natural Oil and Gas Mining in 2010 as amended by Decree of the Minister of Energy and Mineral Resources Number 2322 K/30/MEM/2010;

DECIDES:

To stipulate : REGULATION OF THE MINISTER OF FINANCE CONCERNING ALLOCATION OF REVENUE SHARING FUND OF NATURAL OIL AND GAS MINING NATURAL RESOURCES IN THE CONTEXT OF SPECIAL AUTONOMY IN WEST PAPUA PROVINCE FOR 2010 FISCAL YEAR.

Article 1

Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources in the Context of Special Autonomy in West Papua Province for 2010 Fiscal Year shall be based on the realized revenue of Natural Resource of Natural Oil and Gas Mining Natural Resources for 2010 Fiscal Year.

Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources as referred to in Article 1 is Rp354,233,891,729.00 (three hundred and fifty four billion, two hundred and thirty three million eight hundred and ninety one thousand seven hundred and twenty nine Rupiahs) with the following details:

- a. Allocation of Revenue Sharing Fund of Natural Oil Mining Natural Resources is 55% (fifty five percent) of estimated total state revenue derived from Natural Oil Mining Natural Resources of West Papua Province, amounting to Rp295,824,231,847.00 (two hundred and ninety five billion eight hundred twenty four million two hundred and three twenty one thousand eight hundred and forty seven Rupiahs); and
- b. Additional allocation of Revenue Sharing Fund of Natural Gas Mining Natural Resources is 40% (forty percent) of the estimated total state revenue derived from Natural Gas Mining Natural Resources of West Papua Province, amounting to Rp58,409,659,882.00 (fifty eight billion, four hundred and ninety million six hundred and fifty nine thousand eight hundred and eighty two Rupiahs).

Article 3

- (1) Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources for complete distribution for 2010 Fiscal Year shall be calculated from the difference of realized Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources over revenue of Natural Oil and Gas Mining Natural Resources from December 2009 to November 2010 from the fund distributed until Quarter IV for 2010 Fiscal Year.
- (2) Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources as referred to in paragraph (1) is derived from the Reserve Fund Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources stated in Regulation of the Minister of Finance on Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources for 2010 Fiscal Year.
- (3) In case the limit on estimated allocation of Revenue Sharing Fund stipulated in 2010 Fiscal Year is not enough for the distribution needs or the realization exceeds the limit in 2010 Fiscal Year, the Government shall distribute the allocation of Revenue Sharing Fund

based on the realized revenue in accordance with the provisions of legislation.

#### Article 4

- (1) Additional distribution of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources shall be conducted on a quarterly basis.
- (2) Additional distribution of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources to West Papua Province at Quarter I and Quarter II shall be done respectively at 20% (twenty percent) of the estimated allocation limit.
- (3) Distribution of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources as referred to in paragraph (2) is then calculated with the realized revenue of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources at Quarter III and Quarter IV.
- (4) Distribution of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources as referred to in paragraph (3) shall be implemented based calculation through the data reconciliation mechanism between the Central Government and producing regions.

#### Article 5

At the time this Ministerial Regulation comes into force, [Regulation of the Minister of Finance Number of Estimated Allocations 14/PMK.07/2010](#) regarding Estimate of Revenue Sharing Fund Allocation of Natural Oil and Gas Mining Natural Resources in the Context of Special Autonomy in West Papua Province for 2010 Fiscal Year, as amended by [Regulation of the Minister of Finance Number 183/PMK.07/2010](#) shall be revoked and declared null and void.

#### Article 6

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.  
For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
