REGULATION OF THE FINANCE MINISTER  
NUMBER 101/PMK.011 / 2009  
ON

THE DETERMINATION OF IMPORT DUTY RATES ON SPECIFIC  
MILK PRODUCTS

THE FINANCE MINISTER,

Having considered : a. that in order to support the development of domestic milk industry, it is necessary to determine the rates of import duty on specific milk products;

b. that based on the consideration as referred to in letter a and in order to implement the provision of Article 12 paragraph (3) of Law Number 10 of 1995 on Customs as amended by Law Number 17 of 2006, it is necessary to enact the Regulation of the Finance Minister on the Determination of the Rates of Import Duty on Specific Milk Products;

Having observed : 1. Law Number 7 of 1994 on the Ratification of Agreement Establishing the World Trade Organization (State Gazette of the Republic of Indonesia Number 57 of 1994, Supplement to State Gazette of the Republic of Indonesia Number 3564);

2. Law Number 10 of 1995 on Customs (State Gazette of the Republic of Indonesia Number 75 of 1995, Supplement to State Gazette of the Republic of Indonesia Number 3612) as amended by Law Number 17 of 2006 (State Gazette of the Republic of Indonesia Number 93 of 2006, Supplement to State Gazette of the Republic of Indonesia Number 4661);

3. Presidential Decree Number 20/P of 2005;

4. Regulation of the Finance Minister Number 110/PMK.010/2006 on the Determination of System for Clarification of Goods and Charge of Rates of Import Duty on the Imported Goods as amended several times and last by Regulation of the Finance Minister Number 233/PMK.011/2008;

HAS DECIDED:

To enact : REGULATION OF THE FINANCE MINISTER ON THE DETERMINATION OF IMPORT DUTY RATES ON SPECIFIC MILK PRODUCTS

Article 1

This Regulation determines the rates of import duty on specific imported milk products as set forth in Appendix of this Regulation of the Finance Minister, which shall constitute an inseparable part of this Regulation of the Finance Minister.

Article 2

The provisions of this Regulation of the Finance Minister shall apply to the import of goods the Customs Import Declaration of which has obtained a registration number from the Customs Office of the port of entry.

Article 3

By the operation of this Regulation of Finance Minister, the provisions on the rates of import duty as referred to in Regulation of the Finance Minister Number 19/PMK.011/2009 on the Determination of the Rates of Import Duty on Specific Imported Goods to the extent that they govern products as referred to in the Appendix of this Regulation of the Finance Minister, shall be declared null and void.

Article 4

This Regulation of the Finance Minister shall be effective as of the date of its promulgation.

In order that this Regulation is known to the general public, it is hereby ordered that this Regulation be promulgated in the Official Gazette of the Republic of Indonesia.
