REGULATION OF THE FINANCE MINISTER

NOMOR 107/ PMK.04 / 2009

ON

THE EXEMPTION FROM IMPORT DUTY ON THE IMPORT OF WEAPONS, AMMUNITION, AND MILITARY AND POLICE EQUIPMENT, INCLUDING SPARE PARTS, GOODS AND MATERIALS TO PRODUCE GOODS TO BE USED FOR THE PURPOSE OF STATE DEFENSE AND SECURITY

BY THE GRACE OF THE ONE ALMIGHTY GOD

THE FINANCE MINISTER,

- Having considered : a. that pursuant to Article 25 paragraph (1) letter h and letter I of Law Number 10 of 1995 on Customs as amended by Law Number 17 of 2006, an exemption from import duty is granted on the import of weapons, ammunition, and military and police equipment, including spare parts, goods and materials to produce goods to be used for the purpose of state defense and security;
 - b. that based on the consideration as referred to in letter a, and in order to implement the provision of Article 25 paragraph (3), it is necessary to enact the Regulation of the Finance Minister on the Exemption from Import Duty on the Import of Weapons, Ammunition, and Military and Police Equipment, Including Spare Parts, Goods and Materials to Produce Goods to be Used for the Purpose of State Defense and Security;
- Having observed
 1. Law Number 10 of 1995 on Customs (State Gazette of the Republic of Indonesia of 1995 Number 75, Supplement to State Gazette of the Republic of Indonesia Number 3612), as amended by Law Number 17 of 2006 (State Gazette of the Republic of Indonesia of 2006 Number 93, Supplement to State Gazette of the Republic of Indonesia Number 4661);
 - 2. Presidential Decree Number 20/P of 2005;



HAS DECIDED:

To enact

: REGULATION OF THE FINANCE MINISTER ON THE EXEMPTION FROM IMPORT DUTY ON THE IMPORT OF WEAPONS, AMMUNITION, AND MILITARY AND POLICE EQUIPMENT, INCLUDING SPARE PARTS, GOODS AND MATERIALS TO PRODUCE GOODS TO BE USED FOR THE PURPOSE OF STATE DEFENSE AND SECURITY

Article 1

For the purpose this Regulation of the Finance Minister, the following words have the following meanings

- 1. Minister is the Finance Minister of the Republic of Indonesia.
- 2. Director General is Director General of Customs and Excise.
- 3. Customs Office in the context of the granting of exemption from import duty for the purpose of state defense and security, hereinafter referred to as the Customs Office, is a General Service Office (KPU) for Customs and Excise, or a Customs and Excise Service and Supervision Office (KPPBC).
- 4. Master List hereinafter referred to as RIB (*Rencana Impor Barang*) is a list of goods and materials to be imported by a particular industry for the purpose of state defense and security during a certain period of time which has been approved and validated by Director General of Defense Facilities in the Ministry of Defense, Logistics Assistant to TNI Commander, Deputy of Logistics of Indonesian National Police, or an official whose position is equal to an echelon I official and who is appointed by the Defense Minister or TNI Commander or the Chief of Indonesian National Police.

Article 2

The exemption from import duty shall be granted to imported goods as follows:

- a. Weapons, ammunition, and military and police equipment, including spare parts, goods and materials for the purpose of state defense and security;
- b. The goods and materials used to produce goods which will be used for the purpose of state defense and security.



Article 3

- Imported goods as referred to in Article 2 letter a shall be goods which are used by the Presidency, the Ministry of Defense, the Headquarters of Indonesian National Police, the State Intelligence Agency, or the State Cryptography Agency.
- (2) Imported goods as referred to in paragraph 1 shall be goods as set out in Appendix I, Appendix II, Appendix III, Appendix IV, and Appendix V of this Regulation of the Finance. Minister.

Article 4

- (1) Imported goods as referred to in Article 2 letter b shall be goods and materials used by a particular industry which is approved by the government to be the producer of goods for the purpose of state defense and security, and to produce goods for the purpose of state defense and security.
- (2) Imported goods as referred to in paragraph (1) shall be goods and materials as set forth in Appendix IV of this Regulation of the Minister of Finance.

Article 5

- (1) Goods as referred to in Article 2 letter a shall be imported by the following agencies/institutions;
 - a. The presidency;
 - b. Ministry of Defense;
 - c. Headquarters of Indonesian National Army (TNI);
 - d. Headquarters of Indonesian National Police;
 - e. State Intelligence Agency;
 - f. State Cryptography Agency.
- (2) The import of goods as referred to in Article 2 letter a may be carried out by any third party, pursuant to a cooperation agreement with the presidency, the Ministry of Defense, the Headquarters of Indonesian National Police, the State Intelligence Agency, or the State Cryptography Agency.



(3) Goods as referred to in Article 2 letter b shall be imported by a particular industry which is determined by the Government as a producer of goods for the purpose of state defense and security, pursuant to a cooperation agreement or a Purchase and Sale Agreement with the Ministry of Defense, the Indonesian National Army and/or the Indonesian National Police.

Article 6

- (1) In order to obtain an exemption from import duty on the import of goods as referred to in Article 2 letter a, an institution/an agency as referred to in Article 5 paragraph (1) and any third party as referred to paragraph (2), shall submit an application letter to the Head of Customs Office at the point of entry of goods in the format as prescribed in Appendix VII, Appendix VIII, Appendix IX, Appendix X, Appendix XI, Appendix XII of this Regulation of the Finance Ministry, and attach the following documents:
 - a. Required supplementary customs documents such as invoice, bill of lading/airway bill, and packing list; and
 - b. cooperation agreement for the procurement of goods expressly stating that the price in the cooperation agreement excludes payment of import duty, if the goods are imported by a third party.
- (2) The application letter as referred to in paragraph (2) shall be signed by:
 - a. Secretary in the State Secretariat if the goods are imported by the Presidency;
 - b. Director General of Defense Facilities in the Ministry of Defense or an echelon I official who is appointed by the Minister of Defense if the goods are imported by the Ministry of Defense;
 - c. Logistics Assistant or Vice Logistics Assistant to the Commander of Indonesian National Army if the goods are imported by the Indonesian National Army;
 - d. Deputy Head of Logistics Affairs in the Indonesian National Police if the goods are imported by the Indonesian National Police;
 - e. Principal Secretary or an echelon I official who is appointed by the Chief of the State Intelligence Agency if the goods are imported by the State Intelligence Agency;



- f. Principal Secretary in the State Cryptography Agency if the goods are imported by State Cryptography Agency;
- (3) The application letter shall include the description of goods and the code number as set forth in Appendix I, Appendix II, Appendix III, Appendix IV, and Appendix V of this Regulation of the Finance Ministry.
- (4) For an application letter which fulfills the requirements as referred to in paragraph (1), paragraph (2), and paragraph (3), the Head of Customs office on behalf of the Ministry shall give an endorsement on that application letter as referred to in paragraph (1).
- (5) In the event that the import of goods is granted an exemption from import duty as referred to in paragraph (4) and from import-related tax facilities pursuant to the taxation laws and regulations, the approval / endorsement shall be given to the application as referred to in paragraph (1), providing that such matter is not governed otherwise pursuant to the taxation laws and regulations.
- (6) In the event that the import of goods is granted an exemption from import duty as referred to in paragraph (4) and from import-related tax facilities pursuant to the taxation laws and regulations, the cooperation agreement for the procurement of goods as referred to in Article 6 paragraph (1) letter b shall expressly state that the price in specified in the cooperation agreement excludes the payment of import-related taxes.

Article 7

In the event that the goods as referred to in Article 2 letter a are to be imported but not included in any of the appendices as referred to in Article 3 paragraph (2), the institution/agency as referred to in Article 5 paragraph (1) and the third party as referred to in paragraph (2) shall submit an application for exemption from import duty to the Minister through the Director General.

Article 8

(1) In order to obtain an exemption from import duty on the import of goods as referred to in Article 2 letter b, the industry as referred to in Article 5 paragraph (3) shall submit an application for an exemption from import duty to the Director General and attach the following documents:



- a. Sale and Purchase Contract which expressly states that the price specified in the sale and purchase contract excludes the payment of import duty and/or import-related taxes, or Cooperation Agreement between the Government and a particular Industry, as referred to in article 5 paragraph (3);
- b. Copy of business license, by showing the original document to the appointed Customs and Excise official;
- c. Copy of decision letter establishing the Industry as a producer of goods for the purpose of state military and security;
- d. Copy of Customs Identification Number (NIK);
- e. Copy of Importer Identification Number (API-P/APIT); and
- f. Copy of Master List (RIB) which has been approved and validated by the relevant official and made in the format as prescribed in Appendix XIII.
- (2) To an application which fulfills the requirements as referred to in paragraph (1), the Director General on behalf of the Minister shall issue a decision on the exemption from import duty.
- (3) To an application which fails to fulfill the requirements as referred to in paragraph (1), the Director General on behalf of the Minister shall issue a rejection letter specifying the reason(s) for such rejection.
- (4) Head of Customs Office shall supervise the type and quantity of imported goods granted an exemption from import duty by using a control card.

Article 9

In the event that the goods as referred to in Article 2 letter b are to be imported but not included in any of the appendices as referred to in Article 4 paragraph (2), the party as referred to in Article 5 paragraph (3) shall submit an application for exemption from import duty to the Minister through the Director General.

Article 10

(1) To the application for exemption from import duty as referred to in Article 7 and Article 9, the Minister shall give an approval or a rejection.



- (2) In the event that the application for exemption from import duty is approved, the Director General or the appointed official on behalf of the Minister shall issue a decision on the exemption from import duty.
- (3) A decision on the exemption from import duty as referred to in paragraph (2) shall specify the quantity, type and customs value of the goods to an exemption is granted and shall mention the selected unloading port.
- (4) In the event that the application for exemption from import duty is rejected, the Director General on behalf of the Minister shall issue a rejection letter specifying the reason(s) for such rejection.

Article 11

Appendix I, Appendix II, Appendix III, Appendix IV and Appendix V as referred to in Article 3 paragraph (2), Appendix VI as referred to in Article 4 paragraph (2), Appendix VII, Appendix VIII, Appendix IX, Appendix X, Appendix XI, and Appendix XII as referred to in Article 6 paragraph (1) and Appendix XIII as referred to in Article 8 paragraph (1) letter f shall be an integral part of this Regulation of the Finance Minister.

Article 12

By the operation of this Regulation of the Finance Minister, the applications for exemption which are being processed shall be decided pursuant to the provisions as set forth in the Regulation of the Finance Minister Number 29/PMK.04/2008 on the Exemption from Import Duty on the Import of Weapons, Ammunition, and Military and Police Equipment, Including Spare Parts, Goods and Materials to Produce Goods to be Used for the Purpose of State Defense and Security;

Article 13

By the operation of this Regulation of the Finance Minister, the Regulation of the Finance Minister Number 29/PMK.04/2008 on the Exemption from Import Duty on the Import of Weapons, Ammunition, and Military and Police Equipment, Including Spare Parts, Goods and Materials to Produce Goods to be Used for the Purpose of State Defense and Security is revoked and no longer in effect.



Article 14

This Regulation of the Finance Minister shall come into effect on the date of its promulgation.

In order that this Regulation is known to the general public, it is hereby ordered that this Regulation be promulgated in the State Gazette of the Republic of Indonesia.
