# REGULATION OF THE MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA NUMBER 116/PMK.04/2012

# CONCERNING

## SUPPLY OF EXCISE BANDS AND OTHER SIGNS OF EXCISE REPAYMENT

# BY THE GRACE OF GOD ALMIGHTY

### MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA,

- Considering : a. that under the provisions of Article 7 paragraph (4) of Act Number 11 Year 1995 concerning Excise as amended by Act Number 39 Year 2007, the Excise Bands and Other Signs of Excise Repayment provided by the Minister of Finance;
  - b. that the Supply of the Excise Bands and Other Signs of Excise Repayment as referred to in letter a, carried out in accordance with the principles of safety, continuity, effectiveness, efficiency, and providing equal opportunities;
  - c. that based on the considerations set forth in letter a and b, it is necessary to stipulate Regulation of the Minister of Finance concerning the Supply of the Excise Bands and Other Signs of Excise Repayment;
- In View of : 1. Act Number 11 Year 1995 concerning Customs (State Gazette of the Republic of Indonesia Year 1995 Number 76, Supplement to State Gazette of the Republic of Indonesia Number 3613) as amended by Act Number 39 Year 2007 (State Gazette of the Republic of Indonesia Year 2007 Number 105, Supplement to State Gazette of the Republic of Indonesia Number 4755);
  - 2. The Presidential Regulation Number 54 Year 2010 concerning Procurement of Goods / Services of the Government;

#### DECIDES:

To stipulate : REGULATION OF THE MINISTER OF FINANCE CONCERNING THE SUPPLY OF EXCISE BANDS AND OTHER SIGNS OF EXCISE REPAYMENT

### Article 1

In this Regulation of the Minister referred to as:

1. Security Document is securities or precious printed materials and all types of documents or blank

documents from printed material in part or entirely produced through a printing process that due to the nature and function as evidence or information requires protection against fraud or misuse, which documents results of printing activities.

- 2. Excise Bands is Security Document as a payment of excise mark in paper form that has properties / security element with certain specifications and designs.
- 3. Minister is the Minister of Finance of the Republic of Indonesia.

#### Article 2

- (1) Repayment of goods subjected to excise duty carried out by:
- a. Payment;
- b. Sticking of the Excise Bands, or
- c. Affixing another excise marks.
- (2) Excise Bands and other marks of excise repayment as referred to in paragraph (1) letter b and c, provided by the Minister.

### Article 3

- (1) In order to get the Excise Bands providers and / or other marks of excise repayment as referred to in Article 2 it shall be done auction to the goods / services as a provider of Excise Bands and / or other marks of excise repayment.
- (2) The Providers of Excise Bands and / or other marks of excise repayment as referred to in paragraph (1) shall comply with:
- a. Administrative requirements, and
- b. Technical requirements.
- (3) The administrative requirements as referred to in paragraph (2) letter a is:
- a. Requirements stipulated in the legislation governing the guidelines for the procurement of goods / services of the government;
- b. administrative requirements than those as referred to in



letter a, that is:

- 1) Excise Bands providers and / or other marks of excise repayment are state-owned corporate and / or agency or institution engaged in the printing of Security Documents and / or the procurement of security properties based on licenses issued by the relevant government authorities;
- Excise Bands providers and / or other marks of excise repayment are willing to meet government requirements related to the mechanisms and procedures for payment of excise Bands printing result and / or other marks of excise repayment;
- 3) Excise Bands providers and / or other marks of excise repayment are willing to be partners with the Governments with all legal consequences, and
- 4) Excise Bands providers and / or other marks of excise repayment are willing to be imposed penalties amounting to 100% (one hundred percent) of the contract value if it has been named the winner of the auction, but does not do the job.
- (4) The technical requirements as referred to in paragraph(2) letter b, namely:
- a. have a system of monitoring and reporting the electronic production process which can be integrated with the system at the Directorate General of Customs and Excise in the context of supervision;
- b. Have factory and warehouse for storing raw materials and finished goods in the territory of the Republic of Indonesia, and
- c. Have a printing machine which is capable of printing continuous with design specification of the Excise Bands set forth with the production capacity of the whole machine at least 700,000 (Seven Hundred thousand) pieces of Excise Bands per day, especially for the supply of Excise Bands.

### Article 4

Contract of the supply of Excise Bands and / or other marks of excise repayment made with multi-year contracts (multiyear) according to Acts and regulations governing the implementation of the guidelines for the procurement of goods

#### Article 5

The Supply of Excise Bands and / or other marks of excise repayment conducted in accordance with the provisions stipulated in the legislation governing the guidelines for the procurement of goods / services of the government.

#### Article 6

At the time of this Regulation of the Minister comes into force, the Minister of Finance Number 157/PMK.04/2009 concerning Excise Bands and Other Signs of Excise Repayment revoked and declared void.

Article 7

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
