SERVICE RATES OF PUBLIC SERVICES AGENCY RESEARCH AND  
DEVELOPMENT CENTER OF OIL AND GAS TECHNOLOGY "LEMIGAS" IN THE  
MINISTRY OF ENERGY AND MINERAL RESOURCES

MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA,

- Considering :
- a. that under the provisions of Article 9 of Government Regulation Number 23 Year 2005 concerning the Financial Management of Public Service Agency, the agency service rates apply Financial Management of the Public Service Agency stipulated by the Minister of Finance at the suggestion of the minister / head of the institution;
  - b. that the Research and Development Center of Oil and Gas Technology "LEMIGAS" in the Ministry of Energy and Mineral Resources has been designated as the Government Institution which implementing Financial Management of the Public Service Agency based on the Minister of Finance Decree Number 513/KMK.05/2009;
  - c. that the Minister of Energy and Mineral Resources, through the letter Number 4063/84/SJN.K/2012 dated June 19, 2012, have proposed service rates of Public Service Agency Research and Development Center of Oil and Gas Technology "LEMIGAS" at the Ministry of Energy and Mineral Resources;
  - d. that the proposed service rates of Public Service Agency Research and Development Center of Oil and Gas Technology "LEMIGAS" at the Ministry of Energy and Mineral Resources, has been discussed and reviewed by the Assessment Team;
  - e. Based on the considerations as referred to in letter a, letter b, letter c, and letter d, it is necessary to stipulate Regulation of the Minister of Finance concerning service rates of Public Service Agency Research and Development Center of Oil and Gas Technology "LEMIGAS" in the Ministry of Energy and Mineral Resources;

DECIDES:

To stipulate : REGULATION OF THE MINISTER OF FINANCE CONCERNING SERVICE RATES OF PUBLIC SERVICE AGENCY RESEARCH AND DEVELOPMENT CENTER OIL AND GAS TECHNOLOGY "LEMIGAS" IN THE MINISTRY OF ENERGY AND MINERAL RESOURCES.

Article 1

Service Rates of Public Service Agency Research and Development Central of Oil and Gas Technology "LEMIGAS" in the Ministry of Energy and Mineral Resources is a reward for the services provided by the Public Service Agency Research and Development Center of Oil and Gas Technology "LEMIGAS" to the Ministry of Energy and Mineral Resources.

Article 2

Services rates as referred to in Article 1, consisting of:

- a. Services Rates of Exploration Laboratory;
- b. Services Rates of Exploitation Laboratory;
- c. Services Rates of Process Laboratory;
- d. Services Rates of Product Application Laboratory;
- e. Services Rates of Gas Technology Laboratory;
- f. Services Rates of Calibration Laboratory;
- g. Services Rates of Coal Bed Methane Laboratory;
- h. Services Rates of Lubricant Blending Laboratory, and

i. Services Rates of Experts Assistance.

Article 3

Service Rates of Public Service Agency Research and Development Center of Oil and Gas Technology "LEMIGAS" in the Ministry of Energy and Mineral Resources as defined in Article 2 are listed in Appendix are an integral part of this Regulation of the Minister.

Article 4

- (1) Public Service Agency Research and Development Center of Oil and Gas Technology "LEMIGAS" in the Ministry of Energy and Mineral Resources is able to provide services in the field of research, development, engineering technology, assessments and surveys, as well as services in the fields of oil and gas earth based on the needs of the service users through contracts.
- (2) Services rates of Public Service Agency Research and Development Center of Oil and Gas Technology "LEMIGAS" in the Ministry of Energy and Mineral Resources as referred to in paragraph (1) stipulated in the contracts between the Head of Research and Development of Oil and Gas Technology "LEMIGAS" in the Ministry of Energy and Mineral Resources with the service user.
- (3) Head of Research and Development of Oil and Gas Technology "LEMIGAS" at the Ministry of Energy and Mineral Resources must submit a resume contracts with the users of the service to the Minister of Energy and Mineral Resources and the Minister of Finance.

Article 5

- (1) Public Service Agency Research and Development Center of Oil and Gas Technology "LEMIGAS" in the Ministry of Energy and Mineral Resources is able to conduct Operational Cooperation (KSO) with others to improve services in the field of research, development, engineering technology, assessment and surveys, as well as services in the field of oil and gas.
- (2) Service rates which are from the Operational Cooperation (KSO) with other parties as referred to in paragraph (1) is based on a contract of cooperation between the Head of Research and Development of Oil and Gas Technology "LEMIGAS" in the Ministry of Energy and Mineral

Resources with others.

- (3) Head of Research and Development of Oil and Gas Technology "LEMIGAS" in the Ministry of Energy and Mineral Resources must submit a resume of contracts with other parties to the Minister of Energy and Mineral Resources and the Minister of Finance.
- (4) KSO as referred to in paragraph (1) does not include KSO asset utilization.

Article 6

- (1) Against the service users from universities / colleges and government agencies can be given a special rate at a low of 80% (eighty percent) of the rates as specified in the Appendix which is an integral part of this Regulation of the Minister.
- (2) Against service users from the Ministry of Energy and Mineral Resources can be given a special rate at a low of 50% (fifty percent) of the rates as specified in the Appendix which is an integral part of this Regulation of the Minister.
- (3) The students who are completing the final task as evidenced by a letter of recommendation from the supervisor and / or head of department, and a valid student card can be given special rates highest of 25% (twenty five percent) of the rates as specified in Appendix are an integral part of this Regulation of the Minister.
- (4) The method of imposing special rates referred to in paragraph (1), paragraph (2), and paragraph (3) established by Decree of the Head of Research and Development of Oil and Gas Technology "LEMIGAS" in the Ministry of Energy and Mineral Resources with reference of aspects of continuity and development services, purchasing power, the principle of fairness and decency, and fair competition.

Article 7

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
