THE AMENDMENT TO REGULATION OF THE MINISTER OF FINANCE
NUMBER 54/PMK.011/2011 CONCERNING TO THE IMPOSITION OF DUTY
ON THE IMPORTED PRODUCTS SECURITY MEASURES STEEL WIRE ROPE
(STEEL wire ropes) 7312.10.90.00 BY POST RATES

BY THE GRACE OF GOD ALMIGHTY

THE MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA,

- Considering : a. That the imports of Steel Wire Rope (Steel Wire Ropes) has Duty imposed Safeguard Measures as defined in the Regulation of the Minister of Finance Number 54/PMK.011/2011 of Duty Imposition of Safeguard Measures to The Imported Products Steel Wire Rope (Steel Wire Ropes) 7312.10.90.00 by post rates;
- b. That in order to provide legal certainty for the imposition and collection of import duty on products Precautions Steel Wire Rope (Steel Wire Ropes), necessary to improve the description of goods and post rates of import products of Steel Wire Rope (Steel Wire Ropes) Duty imposed Precautions as referred to in sub-paragraph a;
- c. That based on the considerations set forth in paragraphs a and b, it is necessary to stipulate Regulation of the Minister of Finance on the Amendment to the Minister of Finance Number 54/PMK.011/2011 concerning to the Imposition of Duty on the Imported Products Security Measures Steel Wire Rope (Steel Wire Ropes) 7312.10.90.00 by Post Rates;
- In View of : 1. The Presidential Decree Number 56 / P Year 2010;
2. Regulation of the Minister of Finance Number 54/PMK.011/2011 concerning to the Imposition of Duty on the Imported Products Security Measures Steel Wire Rope (Steel Wire Ropes) 7312.10.90.00 by Post Rates;
3. Regulation of the Minister of Finance Number 213/PMK.011/2011 concerning to the Determination System Classification of Goods and the Imposition of Import Duty on Imported Goods;

DECIDES:

To stipulate : REGULATION OF THE MINISTER OF FINANCE ON THE AMENDMENT TO REGULATION OF THE MINISTER OF FINANCE NUMBER 54/PMK.011/2011 CONCERNING TO THE IMPOSITION OF DUTY ON THE IMPORTED PRODUCTS SECURITY MEASURES STEEL WIRE ROPE (STEEL wire ropes) 7312.10.90.00 BY POST RATES.

Article I

The Provisions of Article 1 of the Regulation of the Minister of Finance Number 54/PMK.011/2011 Concerning to the Imposition of Duty on the Imported Products Security Measures Steel Wire Rope (Steel Wire Ropes) 7312.10.90.00 by Post Rates amended so that Article 1 reads as follows:

Article 1

Against imports of steel wire rope (steel wire ropes) in the form:

- a. Spun out of 6 (six) strands of steel wire (strand) is not a spiral twisted, spun with a diameter of 3 mm (three millimeters) up to 52 mm (fifty-two millimeters), cored (core) in the form of wire, rope or cable from the untwisted iron or steel, plated or coated with zinc (galvanized) or brass or not, and are not isolated;
- b. Spun out of 7 (seven) strands of steel wire (strand) is not a spiral twisted, spun with a diameter of 3 mm (three millimeters) up to 52 mm (fifty-two millimeters), cored (core) in the form of wire, rope or cable from the untwisted iron or steel, plated or coated with zinc (galvanized) or brass or not, and is not isolated, but a strand of its, each consisting of:
 - 1) 7 (seven) twisted steel wire with a diameter less than 6 mm spun (six millimeters), or
 - 2) 19 (Nineteen) twisted steel wire with a diameter of 6 mm spun (six millimeters) to 10.9 mm (ten point nine millimeters);
- c. Spun out of 8 (eight) strands of steel wire (strand) is not a spiral twisted, spun with a diameter of 3 mm (three millimeters) up to 52 mm (fifty-two millimeters), cored (core) in the form of wire, rope or cable from the untwisted iron or steel, plated or coated with zinc (galvanized) or brass or not, and is not isolated, but a strand of its, each consisting of 19 (nineteen) twisted steel wire with a diameter of 6 mm spun (six millimeters) to with 16 mm (sixteen millimeters), and
- d. Spun out of 9 (nine) strands of steel wire (strand) is not a

spiral twisted, spun with a diameter of 3 mm (three millimeters) up to 52 mm (fifty-two millimeters), cored (core) in the form of wire, twisted ropes or cables of iron or steel, plated or coated with zinc (galvanized) or brass or not, and is not isolated, are included in the rates heading ex 7312.10.99.00, subjected Duty Precautions.

Article II

1. At the time of this regulation comes into force, the title of Minister of Finance Regulation Number 54/PMK.011/2011 concerning to the Imposition of Duty on the Imported Products Security Measures Steel Wire Rope (Steel Wire Ropes) 7312.10.90.00 by post rates changed into Minister of Finance Regulation Number 54/PMK.011/2011 concerning to the Imposition of Duty on the Imported Products Security Measures Steel Wire Rope (Steel Wire Ropes).
2. This Regulation of the Minister comes into force on the date of promulgation.

So that everyone knows, it is ordered that this Regulation of the Minister be promulgated in the State Gazette of the Republic of Indonesia.
