CONCERNING
THE IMPOSITION OF SAFEGUARD MEASURE IMPORT DUTY ON THE IMPORT OF
CONCRETE WIRES

BY THE GRACE OF GOD ALMIGHTY
THE MINISTER OF FINANCE,

Considering

- a. that based on the results of investigation conducted by the Indonesian Trade Safeguard Committee, it has been evidenced that there was an import surge of concrete wires, which resulted in serious losses (injuries) to domestic industries;
- b. in the effort of following up the results of the investigation as referred to in letter a, the Minister of Trade, through a Letter Number: 776/M-DAG/SD/6/2010 dated June 14, 2010, Number: 1670/M-DAG/SD/10/2010 dated November 3, 2010, and Number: 1853/M-DAG/SD/12/2010 dated December 20, 2010, delivered a proposal on the imposition of Safeguard Measure Import Duty on the import of concrete wires;
- c. that based on the provisions in Article 21 of Presidential Decree Number 84 Year 2002 on the Safeguard Measures of Domestic Industries from the Impacts of Import Surge, safeguard measures shall remain definable in the form of Import Duty by the Minister of Finance;
- d. that based on the consideration as referred to in letter a, letter b, and letter c, and in the effort of implementing the provision in Article 23D item (2) of Act Number 10 Year 1995 on Customs Clearance as amended by Act Number 17 Year 2006, it is necessary to stipulate a Regulation of the Minister of Finance on the Imposition of Safeguard Measure Import Duty on the Import of Concrete Wires;

DECIDES

To stipulate

: REGULATION OF THE MINISTER OF FINANCE ON THE IMPOSITION OF SAFEGUARD MEASURE IMPORT DUTY ON THE IMPORT OF CONCRETE WIRES.

Article 1

The import of concrete wires, namely wires of iron or non-alloy steel, not plated or coated, polished or not polished, containing by weight less than 0.25% of carbon, included in tariff heading ex 7217.10.10.00, shall be subject to Safeguard Measure Import Duty.

Article 2

The Safeguard Measure Import Duty as referred to in Article 1 shall be imposed for three (3) years with the following conditions:

No	Period	Safeguard Measure Import Duty
1	1 st year, with period of one (1) year from date of promulgation of Regulation of the Minister of Finance.	Rp. 7.767/kg
2	2 nd year, with period of one (1) year from the expiry date of the first year period.	Rp. 7.216/kg
3	3 rd year, with period of one (1) year from the expiry date of the second year period.	Rp. 6.665/kg

Article 3

The Safeguard Measure Import Duty as referred to in Article 1 shall be imposed on the importation from all countries, except on concrete wires manufactured by the countries listed in Appendix of this Regulation of the Minister of Finance, which constitutes an integral part of this Regulation of the Minister of Finance,

Article 7

1. This Regulation of the Minister of Finance shall come into force at the date of promulgation.
2. This Regulation of the Minister of Finance shall come into force for three (3) years from the date of enactment of this Regulation of the minister of finance.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
