THE SIXTH AMENDMENT TO REGULATION OF THE MINISTER OF FINANCE
NUMBER 110/PMK.10/2010 ON THE STIPULATION OF GOODS CLASSIFICATION
SYSTEM AND THE IMPOSITION OF DUTY TARIFF ON THE IMPORT OF GOODS

BY THE GRACE OF GOD ALMIGHTY
THE MINISTER OF FINANCE,

Considering

- a. that in the framework of supporting the stabilization of rice price, based on Regulation of the Minister of Finance Number 241/PMK.011/2010 on the Fourth Amendment to Regulation of the Minister of Finance Number 110/OMK/01/2006 on Stipulation of Goods Classification System and the Imposition of Duty Tariff on Imported Goods which was in force on December 22, 2010, on the imported goods in the form of rice which will be used for supply of rice for the poor families and market operation, included in tariff heading (HS) 1006.30.90.00, the imposition of import duty tariff of Rp. 0,-/kg has been stipulated;
- b. that based on the consideration as referred to in letter a, and in the effort of providing clarification regarding the imposition of import duty tariff on the imported goods in the form of rice and pulverized rice, it is necessary to stipulate Regulation of the Minister of Finance on the Sixth Amendment to Regulation of the Minister of Finance Number 110/PMK.010/2006 on the Imposition of Goods Classification System and the Imposition of Import Duty Tariff on the Imported Goods;

- 2 Regulation of the Minister of Finance number 110/PMK.010/2010 on the Stipulation of Goods Classification System and the Imposition of Import Duty Tariff on the Imported Goods as several times amended most recently by Regulation of the Minister of Finance Number 13/PMK.011/2011;

Article I

Stipulating and reconfirming the imposition of import duty tariff on the imported goods in the form of rice and pulverized rice, including rice with tariff heading (HS) 1006.30.90.00 as referred to in Appendix II Number 622 of Regulation of the Minister of Finance Number 110/PMK.010/2006 on the Stipulation of Goods Classification System and the Imposition of Import Duty Tariff on the Imported Goods as several times amended most recently by Regulation of the Minister of Finance Number 13/PMK.011/2011, so that the stipulation for the imposition of import duty tariff on the imported goods in the form of rice and pulverized rice shall be as follows:
