IMPOSITION OF IMPORT DUTY FOR SAFEGUARD MEASURE ON THE IMPORT OF
COTTON YARN OTHER THAN SEWING THREAD PRODUCTS

WITH THE BLESSING OF THE ONE SUPREME GOD

THE MINISTER OF FINANCE

Considering

- : a. Whereas based on the result of investigation of the Indonesian Trade Safeguard Committee, it is proven that there has been increase of the volume of import of cotton yarn other than sewing thread products which cause serious loss to domestic industry;
- b. Whereas in order to follow up the result of investigation mentioned in point a, the Minister of Trade via Letter Number 54 / M-DAG / SD / 1 / 2011 dated 17 January 2011 and Number 499 / M-DAG / SD / 3 / 2011, has been conveyed the proposal for the imposition of Import Duty for Safeguard Measure of cotton yam other than sewing thread products;
- c. Whereas based on the provision of Article 21 of Presidential Decree Number 84 Year 2002 concerning Safeguard Measure for Domestic Industry from the Consequence of Import Increase, Safeguard measure may be determined in the form of Import Duty by the Minister of Finance;
- d. Whereas based on the consideration as intended in point a, point b and point c, and in the context of implementing the provision of Article 23D paragraph (2) of Law Number 10 year 1995 concerning Customs as has been amended with Law Number 17 Year 2006, it is necessary to stipulate Regulation of the Minister of Finance concerning Imposition of Import Duty for Safeguard Measure on the Import of Cotton Yam Other Than Sewing Thread Products;

COTTON YARN OTHER THAN SEWING THREAD

Article 1

- (1) On the import of cotton yam other than sewing thread products, shall be imposed Import Duty for Safeguard Measures.
- (2) Imported products in the form of cotton yarn other than sewing thread products imposed with Import Duty for Safeguard Measures as intended in paragraph (1) shall be as determined in Attachment I to Regulation of this Minister of Finance which shall constitute an inseparable part of this Regulation of the Minister of Finance.

Article 2

The Import Duty for Safeguard Measure as intended in Article 1 shall be imposed for 3 (three) years under the conditions as follows:

No	Periods	Import Duty for Safeguard Measures
1	Year I, in the period of 1 (one) Year as of the promulgation of this Regulation of the Minister of Finance.	Rp. 40,687 /kg
2	Year II, in the period of 1 (one) Year as of the date of expiration of Year I period.	Rp. 38,144 /kg
3	Year III, in the period of 1 (one) Year as of the date of expiration of Year II period.	Rp. 35.601 /kg

Article 3

The Import Duty for Safeguard Measures as intended in Article 1 shall be imposed on all import from all countries except cotton yarn other than sewing thread products manufactured from the countries stipulated in Attachment II to this Regulation of the Minister of Finance, which shall constitute an inseparable part of this Regulation of the Minister of Finance.

Article 4

- (1) The Imposition of Import Duty for Safeguard Measures as intended in Article 1 shall constitute:
 - a. supplement to general import duty (Most Favored Nation); or
 - b. supplement to preference import duty based on the schemes of international goods trade applicable in the terms of import from the countries included in the relevant international goods trade agreement schemes and upon the fulfillment of the conditions of international goods trade.
- (2) In the event of failure to meet the international goods trade agreement scheme, the imposition of Import Duty for Safeguard Measure for the import from the countries included in the international goods trade agreement schemes as intended in paragraph (1) point b shall constitute supplement to general import duty (Most Favored Nation) as intended in paragraph (1) point a.

Article 5

For the import of cotton yam other than sewing thread products from countries exempted from the imposition of Import Duty for Safeguard Measure as intended in Article 3 and countries having international goods trade cooperation with Indonesia as intended in Article 4 paragraph (1) point b, the importer must submit Certificate of Origin.

Article 6

The provision concerning the imposition of Import Duty for Safeguard Measures as intended in Article 2 shall be fully applicable to the import of goods the relevant import customs notification documents of which obtains registration number from the Customs Office of the import seaport as of the applicability date of this Regulation of the Minister of Finance.

Article 7

1. This Regulation of the Minister of Finance shall be applicable for 3 (three) years as of the promulgation date of this Regulation of the Minister of Finance.
2. This Regulation of the Minister of Finance shall come into force as of its stipulation date
