REGULATION OF THE FINANCE MINISTER
NUMBER 95/ PMK.011 / 2009
ON

THE AMENDMENT OF REGULATION OF THE FINANCE MINISTER
NUMBER 39.1/PMK.011/2008 ON THE IMPOSITION OF ANTI-
DUMPING DUTIES ON THE IMPORT OF HOT ROLLED COILS FROM
CHINA, INDIA, RUSSIA, TAIWAN, AND THAILAND

THE FINANCE MINISTER,

- Having considered :
- a. that pursuant to Regulation of the Finance Minister Number 39.1/PMK.011/2008 on the Imposition of Anti Dumping Tariff on the Import of Hot Rolled Coil from China, India, Russia, Taiwan and Thailand, Anti Dumping Duties have been imposed on the imports of Hot Rolled Coils from China, India, Russia, Taiwan and Thailand;
 - b. that in order to provide legal certainty, it is necessary to make amendments to the list of the companies which are subject to Anti Dumping Duties pursuant to the provision as referred to in letter a;
 - c. that based on the considerations as referred to in letter a and letter b, it is necessary to enact Regulation of the Finance Minister on the Amendment of the Regulation of the Finance Minister Number 39.1/PMK.011/2008 on the Imposition of Anti Dumping Duties on the Imports of Hot Rolled Coil from China, India, Russia, Taiwan and Thailand.

Having Reviewed : Letter of the Trade Minister Number 243/M-DAG/2/2009 dated 18 February 2009 on the Proposal for a Change in the Name of Chung Hung Steel Company into Chung Hung Steel Corporation;

HAS DECIDED

To enact: : THE AMENDMENT OF REGULATION OF THE FINANCE MINISTER NUMBER 39.1/PMK.011/2008 ON THE IMPOSITION OF ANTI-DUMPING DUTIES ON THE IMPORT OF HOT ROLLED COILS FROM CHINA, INDIA, RUSSIA, TAIWAN, AND THAILAND

Article I

A number of provisions of the Regulation of the Finance Minister Number 39.1/PMK.011/2008 on the Imposition of Anti Dumping Duties on the Import of Hot Rolled Coil from China, India, Russia, Taiwan and Thailand shall be amended to read as follows:

1. The provision of Article 1 paragraph (2) Roman number IV number 1 is amended and Article 1 paragraph (2) Roman number IV shall read as follows:

Article 1

- (2) The name of producer/exporter of goods and the amount of Anti Dumping Duties imposed on import of goods as referred to in paragraph (1) shall be as follows:

2. Between Article 2 and Article 3, 1 (one) article namely Article 2A is inserted and shall read as follows:

The provisions on the imposition of Anti Dumping Duties as referred to in Article 1 shall apply to the imports of goods the Customs Import Declaration of which has obtained a Registration Number from the Customs Office of the port of entry since this Regulation of the Finance Minister comes into effect.

Article II

This Regulation of the Finance Minister shall be effective as of the date of its enactment.

In order that this Regulation is known to the general public, it is hereby ordered that this Regulation be promulgated in the Official Gazette of the Republic of Indonesia.
